This document has been prepared in order to fulfill the disclosure liability related with your rights and process of your personal data (all kinds of information of real person whose identity is certain or may be specifiable such as name, surname, address, phone number collected and/or submitted to www.ambalajkongresi.org and www.packagingcongress.org as per the law) by Ultra Turizm A.Ş as "Data Responsible" within the frame of 10th article of the Law of Protecting Personal Data ("Law") numbered 6698.

The data responsible in scope of the law for processing personal data is Ultra Turizm A.Ş located in Balmumcu Barbaros Bulvarı Morbasan Sok. Koza İş Merkezi B Blok No: 12 Kat: 1 Beşiktaş /İSTANBUL. Your personal data is processed and maintained by Ultra Turizm AŞ. in accordance with the law.

PURPOSES OF PROCESSING PERSONAL DATA

Ultra Turizm may process your personal data with the purposes such as maintaining for obligatory/necessary/beneficial transactions as per the law, the necessity for organization and/or service supply for ASD Packaging Congress 2019 *International Packaging Industry Congress*, the necessity of Ultra Turizm to provide service to respondents in scope of the agreement, to record the identity, address, tax number and other data for the determination of the holders and respondents of all kinds of works and transactions to be realized in scope of them, to issue documents and information which shall be basis to the works and transactions in hardware and electronic environment.

METHOD OF COLLECTING PERSONAL DATA AND CAUSE OF ACTIONS

Personal Date is collected by Ultra Turizm on the basis of legal consequences in order to fully and correctly fulfill the its liabilities arising from the laws and agreement in accordance with the above purposes and in oral, written or electronic environment through all tools and channels in scope of the performance and establishment of contracted and non-contracted commercial relations and/or to provide product and/or service to the respondents of ASD Packaging Congress 2019 *International Packaging Industrial Congress*. The above personal data which are collected due to cause of action are processed and transferred with the purposes and conditions of Personal Data Process mentioned in 5th and 6th articles of the law in accordance with the main principles of the law by Ultra Turizm.

Ultra Turizm shall collect the personal data only for definite, clear and legal purposes and shall maintain the data during the period required by the purposes of processing personal data which is explained in above section, shall not process the personal data in the form incompatible with the purposes of personal data processing and shall delete, remove or make the personal data anonym directly or upon the demand of relevant person except the conditions for preserving obligation by law.

RIGHTS OF PERSONAL DATA HOLDERS

As per 11th article of the law, the holders of personal data may apply to www.ambalajkongresi.org and www.packagingcongress.org and have the rights;

to learn whether the personal data is processed,

to demand information if the personal data is processed,

to learn whether the personal data is used in accordance with the process purposes,

to know the third persons in domestic and abroad to whom the personal data is transferred,

to demand correction in case the personal data is processed deficiently or incorrectly,

To demand the removal/ deletion of Personal data within the frame of the conditions in 7th article of law,

to demand the notification of third persons to whom the personal data is transferred about the transactions made as per (d) and (e) clauses,

to object to the occurrence of a consequence against him by analyzing the processed data through exclusive automatic systems,

to demand the compensation in case of damage confronted due to the process of personal data in contrary to the law.
